LREC Relocates Lines for Norwood Hill Road Project

Midwestern Electrical, a contractor hired by Lake Region Electric Cooperative (LREC), has relocated and reconstructed five and a half miles of power lines on Four Mile Road from 780 Road past Norwood School to County Line Road.


Norwood School to County Line Road was a planned system improvement upgrade. This portion of work was a part of this year's work plan. The relocation of Norwood Hill road was a joint effort with Cherokee County and LREC.

The Norwood Hill road project meant LREC needed to move electric conductors from existing poles to new poles along Four Mile Road so the county could start their work on relocating the road.

This road project will take out the sharp "S" turns on Norwood Hill. LREC has been working with the county, construction contractors, right-of-way contractors, and local landowners in the area. Tree clearing was required for the new right-of-way.

Approximately 100 old poles were removed and 125 new poles have been set. These new poles are a larger class pole, they are stronger than the old poles, making our service safer and more reliable.

Even if you plan to be away just a few days, you can save energy in your home when you travel. Here are some tips from Lake Region Electric Cooperative that can give your utility bill a break when you take a break

Water heater: Turn down the temperature, so it doesn't keep the water warm while you are away.

Thermostat: With everyone out of the home for a few days, there is no reason to keep the air conditioning running, unless pets will be left at the house. Even with a pet in the home, you should not set the thermostat for 72 when there is no one there to enjoy it.

Lights: Turn off all lights in your home. You may want to install timers on one or two lights for security.

Electronics: Unless you are recording something while away, unplug all of your electronic devices—computer, monitor and printer, TV and cable boxes, DVD player, microwave, and digital clocks. Any electronics with digital displays, or instant-on features will consume energy even if they are not in use.

Many of the campers were not ready for the week to end.


"Thanks for one of the best weeks of my life," one camper wrote. "I had so much fun that I wish it was two weeks long."

David Rittenhouse demonstrated the power of electricity by burning a hot dog to emphasize the lethal power of electricity. The 22 children were very attentive and enjoyed the safety demonstration.

KAMO Electric Substation Safety Training

Substations are critical parts of Lake Region Electric Cooperative's (LREC) system. Electric substations can be very dangerous places. Only LREC or KAMO employees should be working inside of these substations. Our employees are trained on safety hazards and how to work on substations.

LREC recently joined with KAMO Power, LREC's electric transmission provider, to offer a substation safety training for LREC employees. This training is for employees who may be in a situation where they will have to work inside a substation. These trainings are offered throughout the year at electric cooperatives across the state.

There are many parts of a substation that can cause serious injury and that is one reason LREC

linemen are trained to work inside substations. They take careful precautions before even entering these restricted areas. They always wear hard hats, rubber safety gloves, and fire resistant clothing when working inside the substation and they never enter alone.

LREC employees along with KAMO Power's highly skilled and trained employees are the only people authorized to enter our substations. Give us a call at 918-772-2526 or 800-364-LREC if you have any questions or concerns about a substation or see people inside one of LREC's locked substations.
